

**SUBJECT: DIVISION SCHEDULE OF BRIGADA ESKWELA 2021 BEST IMPLEMENTING
SCHOOLS REGIONAL VALIDATION**

1. Pursuant to Regional Memorandum No. 097, s. 2022 titled "Regional Validation of Division Entries for Brigada Eskwela 2021 Best Implementing School Awards," this Office through the Social Mobilization and Networking Unit under SGOD, hereby announces the schedule of Brigada Eskwela 2021 Regional Validation of the qualifying schools both Secondary and Elementary.
2. Regional Validation schedule is set on **Thursday and Friday, February 17 & 18, 2022** with the assigned Brigada Eskwela 2021 Validators, Regional Office Personnel.
3. The thirteen (13) Qualifying schools are advised to prepare their schools physically guaranteeing that the ambience is festive, ensure orderly compilation of all Brigada Eskwela Forms 1-7 documents and all other supporting labeled MOVs to include Brigada Pagbasa Program Implementation and Documentations.
4. Concerned PSDSs, School Heads and all teachers of the identified schools are advised to be present during the two-day Regional Validation. Thus, adherence to the IATF and DOH Protocols must be strictly observed.
5. The Division Brigada Eskwela Validation Team is scheduled to conduct their monitoring of the best implementing schools on Tuesday and Wednesday, February 15&16, 2022 in preparation for the Regional Validation.
6. Attached is the Official List of Participating Brigada Eskwela 2021 Best Implementing Schools, PSDSs, School Heads and Brigada Eskwela Coordinators. See (*Enclosure 1*).
7. Regional Awarding Ceremony is tentatively set on March 30, 2022.
8. Relative to this, all expenses and logistics incurred shall be charged against School MOOE/ Division Partnership Fund.
