The **DepEd SDO-Tacloban City** through the **BE-LCP Funds 2021** intends to apply the sum of **Six Million One Hundred Eighty Eight Thousand Five Hundred Eighty Pesos (Php 6,188,580.00)** being the Approved Budget for the Contract (ABC) corresponding to payments under the contract for the **PROCUREMENT OF SUPPLIES FOR THE PROVISION OF LEARNING RESOURCES FOR KINDER TO GRADE 3 IN THE IMPLEMENTATION OF BASIC EDUCATION – LEARNING CONTINUITY PLAN (BE-LCP) Batch 3 Lot 2 – A4 size Bond Paper, 80 GSM**. 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

3. Interested bidders may obtain further information from **DepEd SDO-Tacloban City** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
4. A complete set of Bidding Documents may be purchased by interested Bidders from the address below upon presentation of Special Power of Attorney, if not the proprietor, and payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (P5,000.00)** from April 22, 2021 to May 3, 2021.

6. Bids must be delivered to the address below on or before **May 3, 2021, 9:00 A.M.** at the **Conference Hall, DepEd SDO-Tacloban City, Real St., Tacloban City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.



Virtual or online bid opening will also be available for those who could not physically attend due to border or transportation limitations and other challenges brought about by COVID-19 pandemic. Email addresses and/or contact number/s of those prospective bidders who wish to attend virtual/online bid opening should be provided to the BAC Secretariat upon purchase of bid documents.
