 The DepEd SDO-Tacloban City, through the General Appropriations Act (GAA) 2021 under the CY 2021 BASIC EDUCATIONAL FACILITIES FUND (BEFF) - REPAIR OF CLASSROOMS (SAVINGS) intends to apply the sum of Two Million Ten Thousand Four Hundred Sixty-Six Pesos and 14/100 Only (Php 2,010,466.14) being the Approved Budget for the Contract (ABC) to payments under the contract for Lot 1 - REPAIR OF CLASSROOMS at Cirilo Roy Montejo Night High School, Tacloban City. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **DepEd SDO-Tacloban City** now invites bids for the above Procurement Project. Completion of the Works is required **90 Calendar Days after the receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from **DepEd SDO**-**Tacloban City** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.** during office days.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders upon presentation of Special Power of Attorney, if not the proprietor on September 22, 2021 to October 11, 2021 from the given address below or by request to the BAC Secretariat (tcdobacsecretariat@gmail.com) and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos

(*Php 5,000.00*). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

The **DepEd SDO-Tacloban City** will hold a **virtual** Pre-Bid Conference on **September 29, 2021, 9:00 A.M.** at the **Division of Tacloban City Conference Hall, Real St., Tacloban City,** which shall be open to all prospective bidders. - 7. Bids must be duly received by the BAC Secretariat through manual submission or through courier delivery to the office address indicated below **on or before** *October* 11, 2021, 9:00 A.M. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **October 11, 2021, 9:30 A.M.** at the given address below. Bids will be opened in the presence of the bidders/representatives who choose to attend the activity.

**Virtual or online bid opening** will also be available for those who could not physically attend due to border or transportation limitations and other challenges brought about by COVID-19 pandemic. **Email addresses and/or** contact number/s of those prospective bidders who wish to attend the virtual/online bid opening should be provided to the BAC Secretariat upon purchase of bid documents for the link and instructions.
