2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

- 3. Interested bidders may obtain further information from *DepEd SDO-Tacloban City* and inspect the Bidding Documents at the address given below from *8:00 A.M. to 5:00 P.M.*
- 4. A complete set of Bidding Documents may be purchased by interested Bidders from the address below upon presentation of Special Power of Attorney, if not the proprietor, and payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos* (*P5,000.00*) from June 2, 2021 to June 14, 2021.

Bidding documents (*with reference control number*) may also be sent to the Interested bidders via email after presentation of a Special Power of Attorney, if not the proprietor, and a copy of the deposit slip as proof of payment of the nonrefundable fee for the bidding documents by the BAC Secretariat (**tcdobacsecretariat@gmail.com**).

6. Bids must be delivered to the address below on or before June 14, 2021, 9:00 A.M. at the Conference Hall, DepEd SDO-Tacloban City, Real St., Tacloban City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
