- This Division activity shall be participated in by the SDO Top Management Officials, seven (7) Federated Officers, Division Partnership Focal Persons, EPSs, PSDSs, School Principals, Unit Heads (OSDS), 46 SGOD Personnel, Cabalawan ES Teaching and Non-Teaching Personnel, Internal and External Stakeholder-volunteers.

School BE Booth shall be judged based on the following criteria;
 - 1. Creativity- 20%
 - Functionality- 50%

 - 3. Relevance to the theme- 30%
- DFTACT shall be choosing schools to recommend another set of Special awards such as;
 - a. The Most Painted School
 - b. The Most festive and well-organized School
 - c. School with 95-100% Well-prepared Classrooms
