- The schools are given the option to conduct the Portfolio Day in the suggested modality feasible in their situation, such as in-person, blended and/or distance modality.
- Likewise, Districts are empowered to reschedule the activity for a valid reason.
  However, this shall not be a week earlier nor two weeks later than the recommended schedule.
- 4. In case of postponement, a written permission shall be addressed to the Office of the Schools Division Superintendent, attention to the Chief of the Curriculum Implementation Division, one week earlier than the schedule stated above.
- Some activities are suggested for Inclusion in the conduct of the Portfolio Day, but may not be limited to the following:
  - a. Parent-Teacher-Adviser Conference and Feedback-Giving
  - b. Showcase of Learners' outputs; and
  - c. Distribution of Learner's Progress Report/Cards
- With the collaboration of the CID and SGOD, the conduct of the Portfolio Day shall be meaningful and engaging, adhering to the health and safety protocols.
