- DepEd-Tacloban City Division issues a Corrigendum to Division Memorandum No. 417 s. 2022 titled, Localized Guidelines on the Participation of External Stakeholders on Brigada Pagbasa Program.
- 2. Item No. 5 B. c. is corrected as follows:

A total of 16 hours of volunteer service rendered by every Tutor Volunteer is equivalent to one (1) month teaching experience which will be accorded .15 points in the ranking of teaching position in the Schools Division of Tacloban City ONLY.

Item No. 5.B. e.

In addition, the services rendered by the Tutor volunteers during the program duration shall be considered as teaching experience only if:

- c.1. He/she is an applicant under the Registry of Qualified Applicants (RQA) of Tacloban City Division.
- c.2. If he/she is a Licensed Professional Teacher and intends to apply for a Teacher 1 position in the Schools Division of Tacloban City.



- This policy shall apply starting S.Y. 2021-2022 until issuance of new guidelines 4. relative to Brigada Pagbasa implementation.
- All other provisions stated in DepEd Order No. 417 s. 2022 shall remain effective 5. and enforced.
- Immediate dissemination of and compliance with this Memorandum are directed. 6.
