1. 2. The Categories of Awards are:

A. External Stakeholders' Award

1. Kaugop Award- This is an award given to external stakeholders who serve as the primary source of donations and technical support for the Schools in Tacloban City Division. These are those that work in the Local Government Unit and agencies of the government.

2. Kalinya Award- This is an Award given to external stakeholders who intends service to the Schools Division of Tacloban City. These are those agencies or schools that are mostly tapped by the division and/or partner in the implementation of Sulong Educakalidad.

3. Katambulig Award- This is an award given to external stakeholders whose acts of generosity is manifested in the donation given and support extended to promote smooth operations of schools leading to the fulfillment of the Division's desire for a liberating

education. Moreover, an External Stakeholders shall only be eligible for the Division Pasidungog Katambulig Award with any of the corresponding documents:

- With Signed MOA by the SDO
- At least 1 to 2 years in partnership with the School
- With a minimum donated amount of 150,000 pesos.

B. Best Brigada Eskwela Implementers based on DepEd Memo No. 62. s. 2022

C. Brigada Bazaar Awards based on Division memo No. 317 and 353 s. 2022.

3. The Awardees shall be determined upon the monitoring and evaluation of the identified Division Brigada Eskwela Validation Committee composed of PSDS, Socmob Team, Selected Supervisors and Non-Teaching Personnel thus, hereby approved by the Top Management Officials.

4. Schools with active donors but did not meet the criteria for the Division Pasidungog shall be recognized in the School or District Level.

5. A 2-minute video message from external stakeholders shall be submitted to the Socmob Unit on or before October 24, 2021.

6. All participants shall strictly observe the Department of Health (DOH) and IATF protocols.

7. Expenses incurred in this activity shall be charged against Partnership Fund/Adopt-A-School Program and Division MOOE subject to the usual accounting and auditing procedures.
