Each teacher-writer is required to submit a soft-copy of the corresponding *Teaching Video* to their CSE-based competency Teaching Exemplar on or before December 5, 2022, in a specific facebook link provided, for the Elementary: to Miss Gyna Royo at Sto. Nino SPED Center; while for the Secondary: to Mr. Nathan Adornado of V&G National High School, following the required video format posted at the Facebook groupchat for identified CSE writers, in order to receive a Certificate of Recognition as an Instructional Materials developer and a demo-teacher.

4. Expenses incurred of each participant relative to their validation, revision and finalization activities, shall be charged to their local school MOOE and other sources of funds which may be allowed by law, subject to proper accounting and auditing rules and procedures

5. It is likewise advised that all participants shall adhere to increased "time-on-task policy" of the department, to avoid disruption of classes, while observing the new normal' prescribed IATF Health Safety Protocols.
