STRENGTHENING THE IMPLEMENTATION OF "AGAPE" THROUGH VALUES PROGRAM IN SCHOOLS

1. Altering Gap And Personal Experiences (**AGAPE**) through Values Program, is a Division-based initiative in pursuant to varied legal bases such as CSC No. 40 s. 2013 and 2017, Implementation of Values Restoration program, Proclamation no. 479 Moral Recovery Program, DepEd Memorandum no. 572 s. 2006: Anti-Graft and Corruption, DepEd Memo no. 485 s. 2010: Seminars and Symposia on Anti-Graft and Corruption Prevention, Leadership Capabilities and Paralegal Training, Philippine Development Plan 2017-2022 MALASAKIT : Part 2(Enhancing the Social Fabric) Chapter 7, DepEd Order no 40 s. 2012 DepEd Child Protection Policy, The 1987 Constitution of the Phil. Article XIV Section 3 statement 2 and DepEd Memo No. 166 s 2018: National Observance of the Filipino Values Month and the MATATAG vision on promoting learner's well-being. Moreover, the Philippine Constitution particularly Article 2 Section 32 states that *the state shall encourage non-government community-based or sectoral organizations that promote the society's welfare*. Hence, this Division is reiterating the that the previously released Division Memo No. 048 s 2021 entitled "**Life Coaches Participation in AGAPE through Values in School Program**" dated Feb. 2, 2021 is still enforced,
2. To assist the **AGAPE Life Coaches** who served as volunteers in spreading godly values in schools, a **Division-based Life Coaches Training** will be conducted on March 11 and 18, 2023 (2 Saturdays) at Tabernacle Tigbao Diit Tacloban City from 9:00 -5:00 pm and the following are the objectives of the training.
 - a. Evaluate the lessons/curriculum used in teaching
 - b. Conduct Demo-teaching of the material/curriculum used to ensure that the lessons are not a doctrine of any religion, but rather godly values focused.
 - c. Assign Life coaches to specific schools to make sure that no duplication of volunteers is deployed in one school.
3. Teachers and non-teaching personnel involved in this endeavor are entitled a 2 service credits/COC equivalent to 8 hours of service per day under DepEd Order No. 67. s. 1998 and CSC Memorandum Circular No. 09 s. 1988.
4. Expenses incurred relative to this activity are borne personally by the volunteer life coaches.
5. Immediate dissemination of this Memorandum is highly desired.
