1. 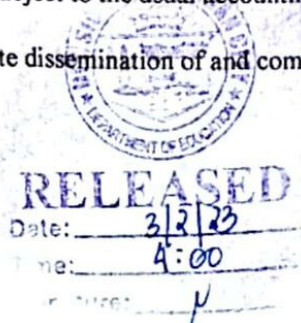
