## ADJUSTMENT OF THE TIMELINE FOR THE IMPLEMENTATION OF SDO'S PROJECT PROWESS

- In conformance to Regional Memorandum 255, s. 2023 (Adjustments and Clarifications on the Conduct of Literacy Assessments Relative to Project BULIG), this Division hereby announces the adjustment of the timeline for the implementation of literacy interventions measures in all schools in line with Project PROWESS (Progressing over Reading Obstacles through Workable, Efficient and Systematic Schemes).
- In this regard, the Post Assessment is now scheduled in June 2023 instead of April 2023. The months
  of April and May shall be devoted to the intensive reinforcement for learners who were not able
  to cope with the 6-month reading interventions, while enrichment for learners who were noted to
  have progressed in their reading performance.
- Meanwhile, the schools are urged to prepare the learners for the Post Reading & Numeracy
  Assessment which will be conducted in the last week of May 2023 for the Division Level and in
  June, 2023 for the Regional level. A separate memorandum will be issued regarding this concern.
- As part of the preparations, the teachers with the supervision and guidance of the school heads, shall conduct classroom reading assessments to keep track of the progress and performance of the learners.
- 5. Contextualized reading assessment tools are prescribed for use, specifically for the Key Stage 1 learners. However, these tools can likewise be utilized to assess the Key Stage 2 learners who have undergone the 6-month interventions. For the secondary learners, the teachers are advised to come up with their own assessment tools.
- 6. Two (2) rounds of classroom assessment shall be conducted by the teachers. The first round shall be done on April 24-28, 2023. The results shall be the basis for further intervention measures. The second round shall be carried out on May 8-12, 2023. Likewise, the results should help the teachers with the necessary help the learners may still need.
- 7. The reading assessment tools shall be shared to the official GCs of Key Stage 1 teachers. Results shall likewise be harvested by the Division through a google sheet.
- 8. Education Program Supervisors, Public Schools District Supervisors and school heads shall continue with the conduct of random reading assessment as part of their supervision and monitoring.
- 9. For information, guidance and strict compliance.
