CONDUCT OF TEENAGE ADVOCACY PROGRAM ACTIVITIES

- 1. In conformity to DepEd Regional Memorandum No. 258, s. 2023 that enjoined the strict compliance of the Executive No. 141, dated June 25, 2021, "Adopting as a National Priority the Implementation of Measures to Address the Root Causes of the Rising Number of Teenage Pregnancies, and Mobilizing Government Agencies for the Purpose" and to raise the level of awareness among our learners, parents, and other stakeholders, this Office, through the Curriculum Implementation Division (CID) directs all Public and Private' Elementary and Secondary (Junior and Senior High) schools of the ten (10) District Learning Centers of Tacloban City Schools Division to conduct Teenage Advocacy Program Initiatives.
- 2. Moreover, all the schools are required to integrate the topics on the Prevention of Teenage Pregnancies, Interventions for the Prevention of Adolescent Pregnancies, Responsible Parenthood, and other related topics encompassing the CSE integration identified entry-point competencies under the Most Essential Learning Competencies (MELCs) in the various learning areas (Health in MAPEH, Araling Panlipunan, Edukasyon sa Pagpapakatao, Science, SHS Personality Development, Kindergarten and Career Guidance) in consonance with the Comprehensive Sexuality Education (CSE) program implementation, and this CSE -related initiatives/activities should be included in the crafting of Annual Implementation Plan as well as in the School Improvement Plan as one of the key PPAs in order to be allocated with appropriate implementation funds and be sustained as best practices of the school.
- 3. In this connection, the SGOD's Education Programs Supervisors for Programs, Activities and Projects, Health and Nutrition Unit, CID's Education Programs Supervisors of the five (5) academic subject areas identified above for the CSE concepts integration and all the Public Schools District Supervisors (PSDSs) of the ten (10) District Learning Centers shall ensure that all schools are monitored to ensure that Teenage Advocacy Program Initiatives or Activities are religiously conducted and provided with the appropriate technical assistance.

- 4. Likewise, a consolidated narrative and pictorial report (comprehensive ACR in hardcopies) of all initiatives relative to this concern, shall be submitted for approval, recording and documentation through the CID Chief, with the corresponding softcopies sent to the Official CID email add.: cidsdotacloban@deped.gov.ph and at the designated online google link to be shared in the CID and Official PSDSs Groupchats, every last Monday of the Quarter starting this quarter of SY 2022-2023 and onwards.
- Immediate dissemination of and compliance with this Memorandum are desired. 5.
