FRAMEWORK ASSESSMENT PROCESS AND TOOL (APAT)**

1. This Office through the School Governance and Operations Division informs the field on the resetting of schedule for the "Regional Division-Based Coaching On The Revised SBM Framework Assessment Process And Tool (Apat)" from its original timetable dated August 14-16, 2023 to a later date on September 13-15, 2023 in a venue to be announced later.
2. This Regional Division-Based Coaching on the Revised Schol-Based Management (SBM) Framework Assessment Process and Tool (APAT) aims to:

 - d. know how to document per dimension properly.
3. This SBM Training is likewise anchored on and in observance of the Harmonized Gender and Development Guidelines (HGDG) as stipulated in the Division Memorandum No. 431, s. 2023. Thus, the training organizers utilize the HGDG Tool in the implementation of this Division Activity.
4. Participants to this activity include the Division SBM Composite Team, PSDSs, and School Heads of Public Elementary and Secondary Schools.
