- 1. The Division of Tacloban City, as one of the divisions in Region VIII, is doing its best to deliver quality education through relevant curriculum, complete resources, inclusive education, a positive learning environment, and support for teachers. Furthermore, the Division is providing opportunities for learners from elementary and secondary, as well as those in the Alternative Learning System (ALS), Indigenous People Education, Special Needs Education Program (SNEd), and Madrasah Education Program (MEP), to demonstrate their best products, services, and performances as authentic pieces of evidence of their learning across academic areas, key stages, inclusion, and special curricular programs through a Festival of Talents in school, district, and division.
- 2. Relative to the conduct of the festival of talents, the division will disseminate schedules of the conduct of the school, district, and division festivals of talents and the tentative schedule of the regional and national festivals of talents for the school year 2023-2024.
- 3. All schools are advised to submit a proposal on the conduct of the School Festival of Talents to the district for endorsement and to the division for approval. The schools are free to choose any event to conduct from the list attached in enclosure A based on the availability of school facilities. Expenses incurred relative to school activities shall be charged against School MOOE, subject to the usual accounting and auditing rules and regulations.
- 4. Likewise, all districts are advised to submit a proposal on the conduct of the District Festival of Talents to the division for approval. Moreover, the districts are advised to conduct all events attached to enclosure A. Expenses incurred relative to the district activities shall be charged against the Special Educational Fund (SEF), subject to the usual accounting and auditing rules and regulations.
