**SUBJECT:** **CORRIGENDUM TO DM NO. 546, s. 2023 ENTITLED CAPACITY BUILDING OF GRADE 7 & 8 TEACHERS IN ENGLISH, SCIENCE, AND MATHEMATICS IMPLEMENTATION OF THE NATIONAL LEARNING CAMP (NLC) BATCH 2**

**DATE:** November 20, 2023

1. In cognizant with Professional Regulation Commission (PRC) to implement RA 10912 otherwise known as *Continuing Professional Development Act of 2016* approved the application of the Department of Education (DepEd) through the National Educators Academy of the Philippines (NEAP) as the accredited CPD provider for teachers through Resolution No. 1032, s. 2017 with Accreditation No. 2017-115. Paragraph 3 of the above provision and the CPD Council for Professional Teachers also agreed that ... "all training programs and initiatives awarded with CPD units shall take into consideration the Philippine Professional Standards for Teachers as reference in identifying the competency development needs of teachers. "Thus, to harmonize the implementation of RA 10912, and to meet the 20-day R8-NEAP, and 45-day PRC timeline, this Office through the Curriculum Implementation Division (CID) informs the field of the **resetting of the Capacity Building of Grade 7 & 8 Teachers in English, Science, and Mathematics on the Implementation of National Learning Camp (NLC) Batch 2 from November 17-19, 2023 to November 24-27, 2023 at the M Grand Royale Resort, Catbalogan Samar.**

Inasmuch as the training-workshop falls on Saturday, Sunday and Holiday, the teacher-participants, facilitators and members of the Technical Working Group (TWG) are entitled to a three-day (3) service credits, while facilitators are entitled for a COC as per CSC-DBM Joint Circular No. 4, s. 2004, provided that the following are dully accomplished:
  - a. Accomplishment Report Training attended with pictures,
  - b. Daily Time Record by the person in authority, and;
  - c. Travel Order and Certificate of Appearance.

5. Other provisions stipulated in the Division Memo No. 474, s. 2023, shall remain enforce and in effect.
