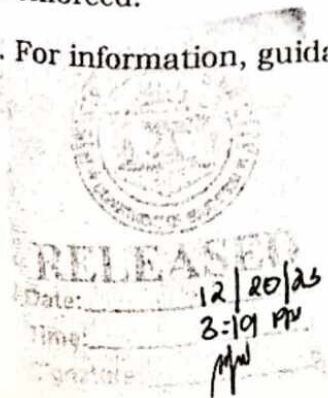
1. To shed light on some issues and concerns relative to the **Conduct of Mayor's Cup Tournament 2024 as per Division Memorandum No. 727 s. 2023**, the Schools Division Office hereby give specific instructions relative to this matter.

2. Paragraph 7 of the aforesaid Division Memorandum is rectified as follows:

- a. *Expenses incurred relative to the conduct of the School, District Meets shall be charged against School MOOE/Local Fund.*
- b. *Further, food, transportation, uniform and other related expenses of the District officials, Coaches and Athletes during the conduct of the Mayor's Cup Tournament shall likewise be charged to School MOOE /Local Fund.*
- c. *However, expenses intended for the Division Officials, Tournament Managers, Officiating Officials, Working Committees and other related expenses in the conduct of Mayor's Cup Tournament shall be charged against Special Education Fund (SEF) subject to the usual accounting and auditing rules and regulations.*

2. All other provisions stated in the Division Memorandum No. 727, s. 2023 are still fully enforced.

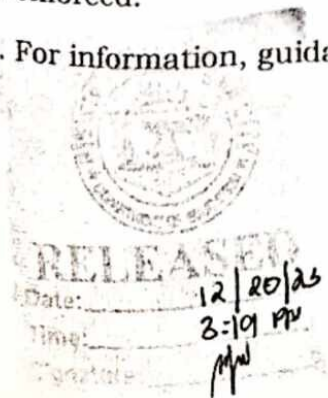
