Division Legal Officer, Planning Officer, and other internal and external stakeholders.

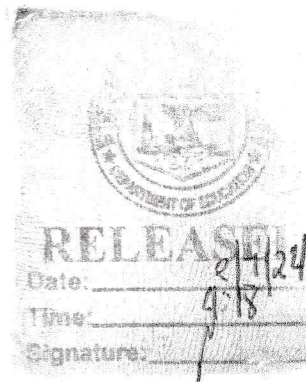
4. Participants are encouraged to wear their Office/ company uniform or business attire.
