1. Pursuant to **DepEd Memorandum OUSIF-2024-0040** dated January 26, 2024 titled **INVENTORY OF SCHOOLS COMPLYING TO BFP REQUIREMENTS**, the Office of the Undersecretary for Schools Infrastructure and Facilities (OUSIF) through the Education Facilities Division (EFD) is requesting assistance in the accounting of schools that are complying with the existing provisions in the Revised Implementing Rules and Regulations (RIRR) of RA 9514 otherwise known as "The Fire Code of the Philippines".
2. In line with the said Memorandum, the School Governance and Operations Division (SGOD) through Education Facilities Section, will consolidate the data to be submitted to the Office of the Undersecretary for School Infrastructure and Facilities (OUSIF).
3. This activity aims to generate data of school buildings that will have to be upgraded to ensure safety of the occupants (i.e. teachers, learners...) and eventually basis for the funding requirements for the identified schools.
4. In addition, each school is required to submit to Education Facilities Section **on or before February 21, 2024 (Thursday)**, through email at rafael.lanza@deped.gov.ph. Attached is a copy of the report template.



