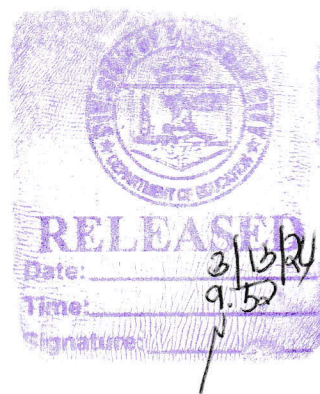
3. Other provisions are stipulated in Division Memo No. 103 s. 2024 shall remain enforced and in effect.
