## CONDUCT OF THE 3-DAY CONCENTRATION TRAINING IN PREPARATION FOR THE EVRAA MEET 2024

- 1. In reference to Regional Memorandum No. 332, s.2024 entitled "Conduct of Eastern Visayas Regional Athletic Association Meet 2024 on May 5-10, 2024, to be hosted by DepEd Ormoc City Division in coordination with the Local Government of Ormoc City, this office through the Schools Governance and Operations Division (SGOD), is pleased to announce the conduct of the 3-Day Concentration Training on April 29 to May 1, 2024, in the different training venue.
- 2. All tournament directors are required to attend the coordination meeting on April 26, 2024 (Friday), 3:00PM at SDO Conference Room.
- 3. The activity aims to:
  - a. strengthen the athletes' necessary skills needed in a team or individual sports competition;
  - b. develop camaraderie among athletes, coaches, chaperones and delegation official; and
  - c. experience and appreciate the value of teamwork in realizing common goals.
- 4. The participants in this concentration training are the Tournament Directors, Athletes, Coaches, Assistant Coaches, Chaperones and Technical Working Group. (see enclosure)
- 5. The participants who render services fall on a weekends and holidays are entitled to Service Credits or Compensatory Time-Off (CTO) whichever is applicable consistent with the rulings under DepEd Order No. 67, s.1988 and CSC Memorandum Circular No. 09, s.1988
- 6. In this regard, the school head shall adopt effective measures to ensure that learners still obtain the full benefit of the curriculum-based

instruction and directed to assign teachers or head teachers to handle the classes left by the participating teachers.

- 7. Further, this office requests that all concerned personnel and learners listed in the attached enclosure shall be excused from their classes from April 29, 2024 to May 1, 2024. It is understood that arrangement will be made for the classes of those athletes, giving them consideration in the submission of subject requirements like projects, and giving them the special examination if they failed to do so because of conflict of schedule with the training camp.
- 8. Expenses incurred relative to the conduct of this activity shall be charged against School MOOE subject to usual accounting and auditing rules and regulations.
- 9. This memorandum will serve as Travel Order of the participants.
- 10. Immediate dissemination of and compliance with this Memorandum are desired.
