### PERFORMANCE BASED BONUS FISCAL YEAR 2022

- 1. In view of the preparation for the grant of Performance Based Bonus (PBB) FY 2022, all schools are requested to accomplish the attached Form 1.0 (List of Eligible and Non-Eligible Employees). The covered period for the grant of the said benefit is August 1, 2022 to July 31, 2023 school-based personnel and January 1, 2022 to December 31, 2022 for the non-school based personnel.
- 2. In preparation of the said report, please be guided of the following:
  - a. An official or employee who has rendered a minimum of nine (9) months of actual service during the SY 2022-2023 and with at least "Satisfactory" performance rating may be eligible for the full grant of PBB 2022;
  - b. An official or employee who rendered less than (9) months but a minimum of three (3) months of actual service during the SY 2022-2023 and with at least "Satisfactory" performance rating may be eligible for the full grant of PBB 2022 on a pro-rata basis corresponding to the actual length of service rendered;
  - c. An employee who is on vacation, sick or personal cases by final and executory leave, with or without pay, for the entire year **shall not be eligible** for the grant of PBB FY 2022;
  - d. Personnel who transferred from one government agency to another shall be rated and ranked by the agency where they served the longest;
  - e. Personnel found guilty of administrative and/or criminal by final and executory judgment in FY 2022 **shall not be eligible** for the grant of PBB 2022;
  - f. An official or employee who failed to submit Statement of Assets, Liabilities and Network (SALN) for FY 2022 shall not be eligible for the grant of PBB FY 2022;
  - g. An official or employee who failed to submit the Individual Performance Commitment Form (IPCRF) for SY 2022-2023 on the deadline set by this Office **shall not be eligible** for the grant of PBB FY 2022.
