In view of the foregoing, as stipulated in DepEd Order 008, amending Paragraph 6, specifically bullet 4 of DO 003, s. 2024 amending DO 022, s. 2023 "Implementing Guidelines on the School Calendar and Activities for SY 2023-2024), shall be amended and read as follows:

- Start and End of SY 2024-2025. School Year 2024-2025 shall start on July 29, 2024 (Monday) and shall end on April 15, 2025 (Tuesday)

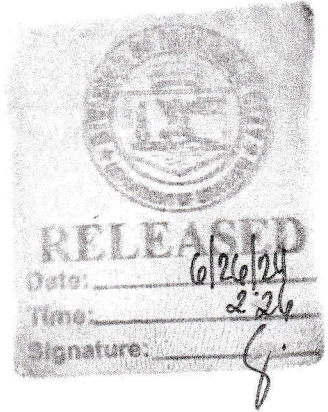
