1. The Division Innovation Review Committee (DIRC) within the Department of Education plays a critical role in evaluating and approving school-based innovation projects. 3. The Division Innovation Review Committee (DIRC) shall assume the responsibilities of managing innovation projects within the schools division. The DIRC shall have the following roles and responsibilities:
 - a. Provide direction on innovation projects to address identified priority improvement areas in the division and schools;
 - b. Evaluate and approved innovation project proposals and other related innovation projects within the schools division;
 - c. Provide technical assistance to proponents on the conduct of their innovation projects;
 - d. Prepare and submit reports to the Regional Innovation Review Committee on all innovation projects conducted in the division;
 - e. Resolve emerging issues in the management and conduct of innovation projects;
 - f. Provide recommendations and feedback to the Division Top Management on approved, on-going and completed innovation projects.
 - g. Others.

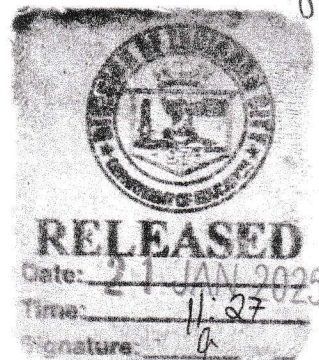
4. The Focal person and secretariat shall deliver the following:
 - a. Organize, coordinate and document meetings of the Committee;
 - b. Conduct initial screening of submitted innovation project proposals for compliance with submission guidelines;
 - c. Aid DIRC members in recommending innovation project proposals for approval as per the criteria and scoring template;
 - d. Provide technical assistance to proponents on the conduct of their innovative projects;
 - e. Conduct periodic monitoring on innovation projects of the school division and schools;
 - f. Review and evaluate the completed innovation project report;
 - g. Prepare periodic report on accomplishments relation to division innovation project;
 - h. Prepare complete staff work in support of the Committee's functions as needed;
 - i. Others.

5. The designation of DIRC is in addition to the respective regular duties/functions without additional compensation and will be in force and effect until sooner revoked by this office.

6. Any previous Memoranda/Special Order, which are inconsistent hereof are deemed revoked, rescinded or modified accordingly.
