1. The Curriculum Implementation Division (CID), through the Alternative Learning System, will conduct an extension on the validation of the Presentation Portfolio Assessment (PPA) and the registration of qualified test takers at Tacloban City Community Learning Center.

- 2. ALS teachers should first check the content of the learner's portfolio before submitting it to the validating team. Acceptance of documents will be until 3:00 p.m. with or without the learner's presence. Only the learners with complete documents, specifically during the PPA, will be allowed to proceed to the registration phase.
- 3. Furthermore, ALS teachers should inform their respective learners of their schedule for a systematic flow of the validation and registration process.
